



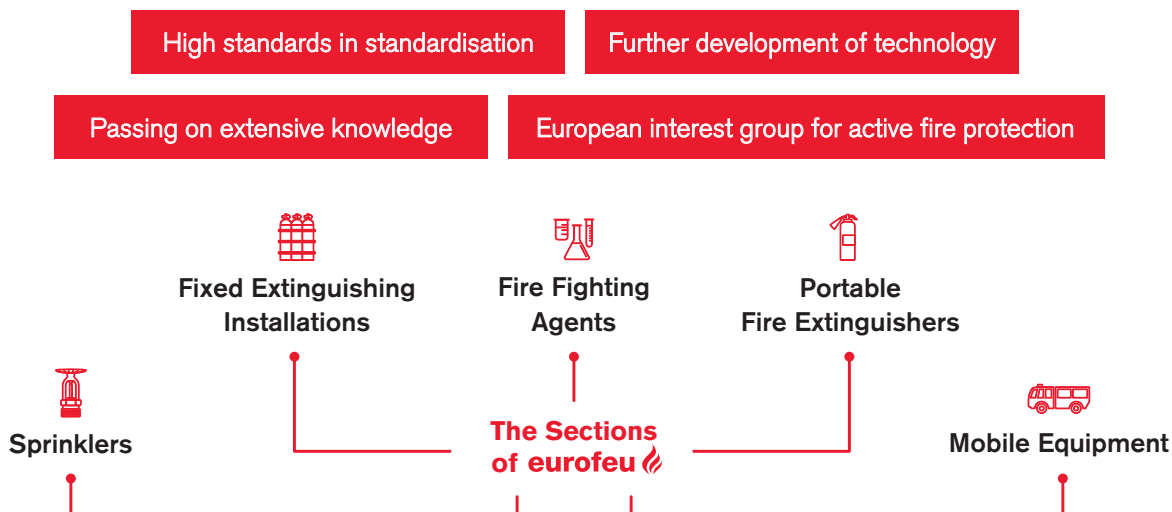
# What is Eurofeu?

# Fixed Extinguishing Installations

This section focuses on extinguishing systems that do not extinguish fires with water. These are CO<sup>2</sup> and inert gas extinguishing systems, other extinguishing systems as well as active fire prevention systems using Oxygen reduction. The consequences of the EU Directives, in particular the Construction Products Directive, the Pressure Equipment Directive and of the European Commission (EC), here the CE Marking Directive, are reviewed and discussed within this section.

Information on other regulations, such as the European Agreement dealing with the international transport of dangerous goods by road and rail, is also an important topic of our work.



The aim of our section **EUROFEU FEI** is to facilitate trans-national cooperation in Europe through effective debate on matters of interest, establishing and maintaining a consensus of opinion which is recognised in Europe and the world as the formal **EUROFEU** position.

In doing so, we seek to achieve common goals of benefit both to the fire protection industry and to its customers. This includes facilitating and promoting the growing use of fixed fire extinguishing systems for the protection of life, property and the environment across Europe.

# Portable Fire Extinguishers

Manufacturers of portable and mobile fire extinguishers are represented in this section. It supports the development of European directives.

Particular topics include the European Standard for Fire Extinguishers (EN 3 series); the Pressure Equipment Directive (Directive 2014/68/EU); the Marine Equipment Directive (Directive 2014/90/UE, and its Implementing Regulation 2017/306); the Convention for the Transport of Dangerous Goods (European Agreement concerning the International Carriage of Dangerous Goods by Road/ADR); Guideline to the CLP Regulation (Guidelines on the Application of the Regulation on the Classification, Labelling and Packaging of Substances and Mixtures).

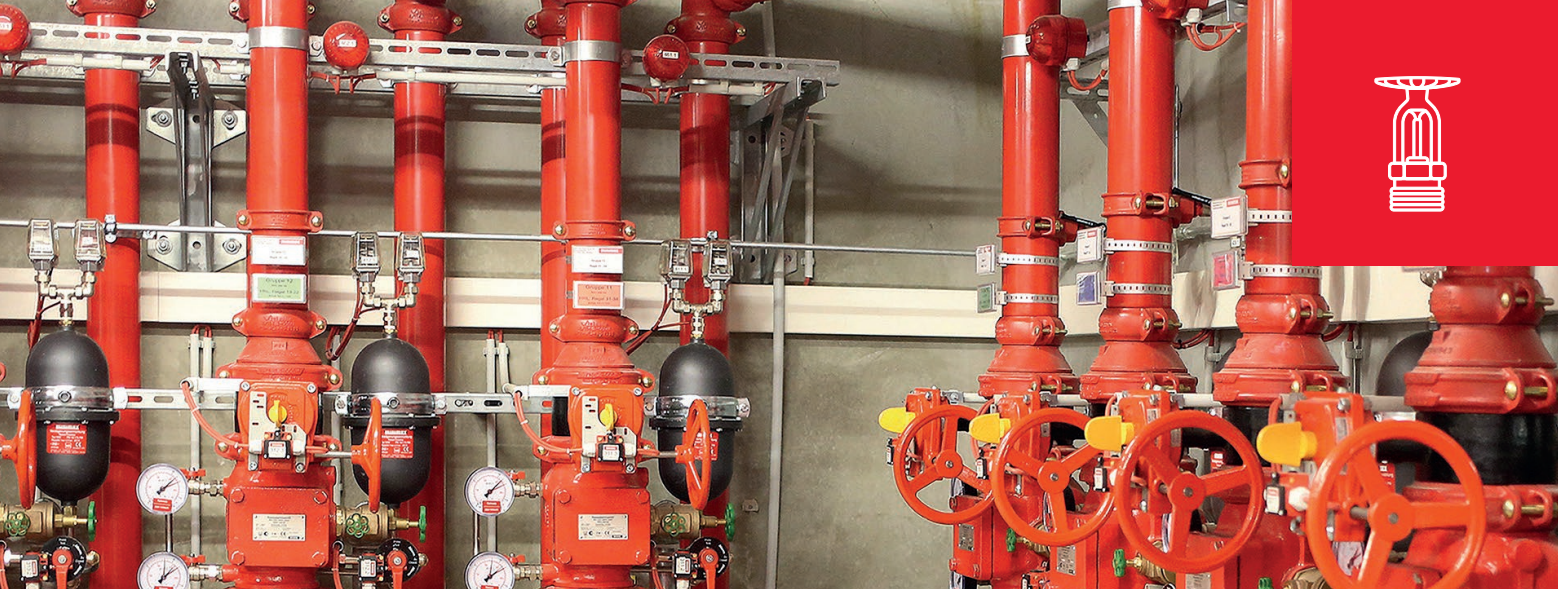
Portable fire extinguishers are valuable in the early stages of a developing fire when their portability and immediate availability for use enable a prompt attack.

# Sprinklers

This section deals with sprinkler systems as well as water spray and water mist extinguishing systems. Members are actively involved in the European and international standardisation process.

# Fire Fighting Agents

In recent years, international and particularly European codes and standards have evolved significantly, as has their influence on our products and businesses. This resulted in the founding of the section Firefighting Agents FFA in 2013. Today – five years later – we are accredited observers to key organisations in Europe such as ECHA and OSPAR, successfully networking with Europe's leading authorities.
